With the academic readiness of campus to implement the NEP compliant curriculum for all the students admitted w.e.f. AY 2023-24, the Chairman assured that all the benefitting features of NEP shall also be to the FAP group of students. The Chairman-Senate further assured the member that he will present these concerns in the upcoming BoG meeting and take necessary actions accordingly. Thereafter the Senate unanimously approved the ATR.
