The item was discussed at length and breadth, with diversified opinions/expressions by the members with respect to a special case of a candidate, brought to the notice of the Senate, and as recommended by the Dept of Applied Science, for conferment of degree of "M.Tech by Research" in 24 months, in place of 30 months, as mentioned in the Ordinance – 2018. The

members agreed on the fact that the ordinance has the discrepancy in terms of minimum 30 months duration of the program, but with "No mention" of academic engagement for the candidate in last (5<sup>th</sup>) Semester.

The members also agreed on the need on correcting the discrepancy in the ordinance at the earliest. However, since the Ordinance rule, in letters, cannot be violated for a specific case, the Senate while appreciating the performance of the student (on a faster track), with all mandated compliances, expressed its inability to help the student, as recommended by the Dept of AS. The academic assignment to be given to the student in his continued 5<sup>th</sup> Semester, was left to be decided by the Dept. of Applied Sciences and the supervisor.

Resolution: S-27/04: The Senate RESOLVED to articulate appropriate corrections for the "M.Tech by Research Program" in the Ordinance-2018, to annul the prevailing ambiguities therein, for its prospective implementation, after moving such corrected ordinance through proper channel.

The Senate further RESOLVED to instruct the concerned student of the 'M.Tech by Research' program to continue with his 5<sup>th</sup> Semester, as mandated on him by prevailing ordinance and as made clear to him in his admission letter.

The Director apprised the members on the proposal of establishing the 'Rekhi Center for Science of Happiness with reference to the MoU signed by the Institute with Rekhi Foundation-USA, in the month of July-2023. With a committed funding support from the foundation in terms of a corpus endowment, annual component for salaries of teachers who would teach the relevant courses, amount for establishing a "Mind lab" and annual component of sundry expenditure etc., the Institute needs to commit introducing/accommodating a set of OPTIONAL courses related to the theme of the Center, in its new UG curriculum, spread across semesters, as value education courses and/or open electives. The Director also updated on a new concept of an optional "Micro" certification, for a student who undertakes the series of thematic (Science of Happiness) courses summing to 08 credits, (like optional 'Minor' or 'Honors'). When queried by a member, the Director clarified that a separate 'Certificate' (distinctly than their Major Degree) will be awarded to the concerned students on successful completion of such optional 'Micro'.
