### **Instructions for Candidates appearing for IIITA-PET on 15-05-2025**

1. IITA-PET May 2025 for shortlisted applicants as published on Institute Website is being conducted in Physical Mode only.
2. IIITA-PET May 2025 is for admissions to the PhD Program commencing from July 2025 ONLY.
3. **Venue of this IIITA-PET May 2025 is IIIT Allahabad campus at Jhalwa, Prayagraj ONLY. Exams will be held in the CC-3 Building Room No.-5041 Ground Floor and waiting area for students, accompanying parents/ guardians is Admin Auditorium in Admin Block.**
4. Candidates **MUST** bring their Aadhar Card / PAN Card as identity proof along with a copy of Application form to the Exam venue in hard copy duly self attested.
5. This IIITA-PET May 2025 is only Computer Based Multiple Choice Questions (MCQ) Test, where each examinee shall be allotted a separate computer terminal for his/her examination. Rough Sheet shall also be provided but responses of correct answers shall have to be marked on the computer terminal for consideration.
6. All examinees are required to enter their answer choices directly on the computer for being considered for evaluation.
7. The Entrance Examination comprises two sections (Sec1 – General Aptitude, Sec 2 – Branch Specific), both carrying 50 marks each. Candidates who have applied for two different branches, shall be allowed extra time of one hour to answer the Sec-2 pertaining to the second branch applied for, in continuity. S/he is not required to repeat the Sec-1 in such cases.
8. There is no NEGATIVE MARKING.
9. **Candidates are allowed to enter into the examination Room from 9:15 am onwards on 15-05-2025.**
10. **From 9:30 am to 9:40 am they shall be allowed a practice window with the Examination Software, with the help of dummy questions. No examinee shall be allowed after 9:45 am in the Examination Room. Attendance shall be recorded during this time. Actual examination shall start from 10:00 am onwards and end at 12 noon.**
11. **The seating arrangements for this IIITA-PET shall be displayed at CC-3 Building of IIIT Allahabad from 8 am of 15-05-2025.**
12. For Gen/ OBC/ EWS/ PH Candidates, minimum marks required to pass the written examination are 40, while for SC/ ST Category candidates, Cut Off marks are 35.

13. The written examination is the screening Examination. Accordingly, the candidates scoring marks equal to or above the specified minimum marks shall ONLY be eligible for the Personal Interview.
- 14. List of candidates invited for personal Interview shall be displayed on the Notice Board in CC3 Building at about 1:30 pm. Personal Interviews shall start immediately thereafter. Venue for personal interview will be displayed at CC-3 Notice Board.**
15. List of finally selected candidates shall be displayed, on or before 22-05-2025 on the Institute website. The list of required Documents shall be intimated to the selected candidates through website information.
16. The selected candidates shall be required to report for registration with all the documents in Original on from 23-06-2025 to 10-07-2025.
17. Throughout this IITA-PET May 2025, IITA is relying on the candidate for all the claims pertaining to his/her academic achievements as well as Category being made by the applicant in his application. The responsibility of producing the relevant Original Records in support, at the time of admission therefore rests solely and completely upon the candidate. In case of any shortfall / misleading information found at any stage, the admission of the candidate shall be cancelled ab initio, with all liabilities arising, whatsoever on the candidate himself. No change in category is allowed at any stage.
18. **No calculator/ electronic device/ cheat sheet/slip of any kind is allowed in the examination hall.** Candidates may be frisked upon entry during examination and shall be personally responsible for the outcome. In case any objectionable/ unwarranted material is recovered from the candidate s/he shall be removed from the examination hall forthwith and debarred from further participation in the IITA-PET.
