

# **Advertisement for Faculty Recruitment**

Indian Institute of Information Technology, Allahabad (IIITA) at Prayagraj (U.P.) is an Institute of National Importance established in 2000 by the Ministry of Education, Government of India. The Institute offers B.Tech., M.Tech., M.B.A, Ph.D., and other programs of contemporary relevance to the aspiring learners, in the broad areas of Applied Sciences, Electronics and Communication Engg., Information Technology, Management Studies and their associated niche domains.

IIITA invites application for the posts of **Professor**, **Associate Professor**, **Assistant** Professor (Grade-I) on regular positions and Assistant Professor (Grade-II) on individuals Doctoral contract, from having degree from Institutions/Universities from India and abroad with an excellent scholastic record in academics, high quality research, and commitment to teaching under 4-Tier-Flexible faculty Structure in the disciplines of Information Technology, Electronics and Communication Engineering, Applied Sciences, and Management Studies. Preference will be given to the candidates belonging to reserved categories (SC/ST/OBC-NCL/PwD/EWS), who qualify the eligibility and other requirements as detailed herewith.

# **Selection Procedure**

1. After Screening, the shortlisted candidates shall be invited for presentation followed by interview before the Statutory Selection Committee in person. To and fro fare upto AC 3 tier by the shortest route (only for travel within India) will be paid by the institute on submission of tickets. Tatkal

charges and local travel charges shall not be reimbursed. Accommodation will be provided in institute's vistors' hostel at institute subsidized rate.

2. Based on the recommendations of the statutory selection committee and approval of the Board of Governors, appointment letters shall be issued.

## **Guidelines**

- 1. The Candidates who had applied earlier need to apply afresh. Old application will not be considered.
- 2. Candidates are advised to fill the information carefully in the online application form. Institute will neither be responsible for any wrong information furnished nor accept any subsequent requests for making any corrections by the candidate(s). The candidate(s) shall be solely responsible for the information filled in the online application form. No change/deviation, whatsoever, will be entertained.
- 3. The candidates of General, OBC-NCL and EWS categories are required to pay non-refundable application fee of Rs. 1,000/- only whereas the candidates of other reserved categories are required to pay non-refundable application fee of Rs. 500/- only. 4. Incomplete/ partially filled application forms will not be considered. The decision of the Institute authorities in such cases will be final.

- 5. The applicants are required to upload all the supporting documents mandatory to complete the applications.
- 6. Separate sheet, if required, may be attached along with application.
- 7. As it is a rolling advertisement, the Institute reserves the right to fill/partially fill or not to fill any vacancies or cancel the selection process wholly or partially based on the availability of vacancies in particular category at the time of presentation/interview.
- 8. Canvassing in any form will be a disqualification.
- 9. Applications sent through email/FAX will not be considered.
- 10. Essential and other essential qualifications/requirements are minimum eligibility criteria. Short listing criteria for presentation/interview may be fixed at higher levels subject to the number of vacancies available and the number of application received.
- 11. A candidate applying for a post can be called for interview for lower post also, if Committee recommends so.
- 12. Mere eligibility will not entitle any candidate for being called for any part of selection process. The Institute reserves the right to relax any of the qualifications/experience in exceptional cases.
- 13. Applicants who are employed in Government or Semi-Government Organizations should apply through proper channel or produce a "No Objection Certificate" from their employer at the time of presentation/interview.
- 14. No information will be sent to those candidates who are not screened-in or not shortlisted for Interview.
- 15. Candidates may apply in more than one department by repeating the online application process.
- 16. The candidates belonging to reserved category are required to attach the Category certificate in the prescribed format of the Government of India, issued by the competent authority, not below the rank of a Tahsildar or from a first-class Magistrate of the place of domicile of the candidate clearly authenticating the category to which they belong to.
- 17. The reservations for differently abled persons (PwD) candidates are as per the Govt. of India. However, they shall be required to produce a medical certificate in the prescribed form issued by the competent medical authorities for the purpose of employment. Persons suffering from not less than 40% of the disability in a, b, d, and e category as per the Department of Personnel and Training Office Memorandum No. 36035/02/2017- Estt(Res) dated 15th January 2018 shall only be eligible for the benefit of reservation and other relaxations, if any, as permissible under the rules.
- 18. An EWS candidate shall be eligible for the benefit of reservation and other relaxations, if any, as permissible under the rules as per the Ministry of Social Justice and Empowerment Office Memorandum F.No. 20013/03/2018-BC-II dated 17th January 2019 for reservation of Economically Weaker Sections.
- 19. Candidates must ensure before applying that they are eligible according to the criteria stipulated in the advertisement. If the candidate is found ineligible at any stage of recruitment process, he/she will be disqualified and their candidature will be cancelled.

- 20. Hiding of information or submitting false information will lead to cancellation of candidature at any stage of recruitment. The Institute reserves the right to reject any application without assigning any reason whatsoever.
- 21. Any legal proceedings in respect of any matter of claim or dispute arising out of this advertisement and / or an application in response thereto can be instituted only in Prayagraj and courts/tribunals/forums at Prayagraj only shall have sole and exclusive jurisdiction to try and such cause /dispute.

## Reservation

Reservation is applicable as per Government of India rules. The candidate belonging to reserved categories (SC/ST/OBC-NCL/PwD/EWS) are required to attach the Caste/ Category/Income certificate issued by the competent authority in prescribed format of Government of India. The Institute follows the Central list in the case of SC/ST and OBC-NCLs. OBC-NCL certificate should not be older than one year. The institute also encourages applications from qualified women candidates.

## **Benefits**

IIIT Allahabad makes every attempt to help faculty members settle in their academic role and to grow professionally. The Assistant Professors (on contract) are eligible to receive all the benefits as for regular faculty members. These include:

- 1. Contribution towards New Pension Scheme (NPS), HRA, LTC, medical re-imbursement, transportation allowance, education allowance for children etc. admissible as per the Institute Rules.
- 2. A Cumulative Professional Development Allowance of Rs. 3 Lakhs for every block period of 3 years is available to every member of the faculty to meet the expenses for participating in both national and international conferences, paying the membership fees of various professional bodies, books and periodicals and contingent expenses, as well as for other professional development activities.
- 3. Reimbursement of telephone bills up to a ceiling of Rs.750/-per month.
- 4. Besides pay, the post carries allowances according to the Institute rules which at present correspond to those admissible to the Central Government employees stationed at Prayagraj.
- 5. Good facilities for office and computing.
- 6. Well-stocked library and e-learning.
- 7. Facilities for Research and Development activities in all the Departments and Centers.
