2. The Institute reserves the right to accept application at any time, and consider candidates of exceptional credentials without applications. Qualification and experience may be relaxed at any point of time for exceptional candidates.
3. Mere, possessing the prescribed qualification does not ensure that the candidate would be called for Interview. The Candidates will be shortlisted on the basis of merit and need of the project.
4. Shortlisted Candidates will be informed by e-mail about the interview date.
6. Shortlisted candidates have to present themselves for the interview on the interview date with updated CV and original and attested photocopies of mark sheets/certificates in support of their academic qualifications.
7. Applicants in employment (private, government or any other organization) are required to submit a “No Objection Certificate ” from the employer at the time of interview.
8. No TA/DA will be paid for appearing in the interview.
9. The association between PI and the candidate can be discontinued at any time by giving one month’s notice in writing either by the PI of the project to candidate, or by candidate to the PI of the project.
11. Candidate selected for this position can also apply for the regular PhD program in any of the Departments of IITA, provided they satisfy the eligibility criterion followed by selection process laid down by the institute.
12. After qualifying the PhD admission / selection test the candidate will be registered as regular PhD scholar and eligible to draw the fellowship and other allowances as per the Institute rules.
