2. Preference will be given to the Manufacturer/Sole Distributors.

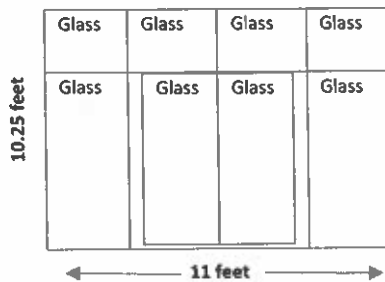

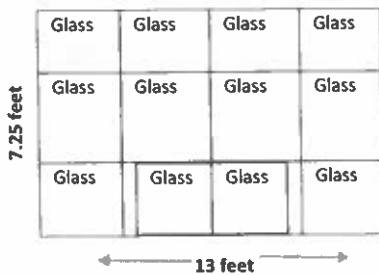
