Scope of Work / Requirements

1. Live Band Services

Professional live band with lead vocalist, instrumentalists, and supporting artists.

Duration of performance: as per programme schedule

Genre: Indian Rock, and Alumni-requested numbers.

2. Sound System Setup

High-quality PA system, mixers, amplifiers, microphones (wired & cordless).

Stage monitors, woofers, subwoofers, and allied sound equipment.

Experienced sound engineers/technicians for the event.

Backup arrangement to ensure uninterrupted performance.

3. Other Requirements

Transportation, setup, and dismantling of all equipment.

Technical rehearsal before the event.

On-site support team during the entire event.

Key Points to Be Noted:

- 1. All conventional wires need to be with extra length of cable and cannot be crossing the main seating areas.
- 2. Generators or main grid power to be calculated and supplied as per required for the above inventory.
- 3. Monitor Position to be on STAGE LEFT, DOWN STAGE with clear view of all the members of the band
- 4. Front Fills D&B V /Y Series, L'Acoustics DvDosc, Arcs or similar should be there.
- 5. A 4-way F.O.H speaker system must be provided to evenly cover the entire venue for the event.
- 6. Should be able to produce 100 dB SPL(A-WEIGHTED/SLOW) at F.O.H position without distortion.
- 7. F.O.H position must not be more than 2 feet off centre of P.A.
- 8. All processing to be made available to the F.O.H engineer for further processing if needed.
- 9. All wireless microphones and IEMs should have a splitter/combiner with UHF directional antennae to ensure complete stage coverage. Any RF dropouts at extremities would be unacceptable.
- 10. All Sennheiser G3 IEMs to be provided, no Shure IEMs to be provided. 15. Please ensure every track of the snake and splitter works perfectly else please make alternate arrangements. 16. Provide Direct SHOUT / Talkback LINES FROM FOH to MONITOR position and VICEVERSA with 2 Switch Microphones and 2 powered Speakers.

Please mention the following details in quotation:

- 1. Company profile with brief details of similar works executed.
- 2. Copies of work orders/completion certificates of at least 3 similar events.
- 3. GST Registration Certificate, PAN, and other statutory documents.
- 4. Undertaking of non-blacklisting.
- 5. List of equipment(s) that your firm can supply.
- 6. Total amount that you would charge for fulfilling all the Electricity Requirements of the event.
- 7. Taxes if any may please be specified separately.
- 8. The bidder/agency must clearly mention the location and complete address of their go-down/warehouse/service facility from where the equipment and manpower will be mobilized and specify the average delivery/response time required to meet any emergency requirements (such as additional sound equipment, cabling, generators, or manpower) during the event.
- 9. The bidder/agency shall furnish details of any contracts already taken up or planned to be taken up during and around the period of the event (September 26–28, 2025). Failure to disclose such engagements may lead to disqualification, cancellation of work order, or forfeiture of payment/EMD (if applicable).

Terms and Conditions:

- 1. The services must be provided as per the schedule of the event.
- 2. Sound and technical setup should be ready at least 4 hours prior to the event commencement.
- 3. **Quality & Standards:** All sound equipment provided must be of professional quality and in perfect working condition. The band/artists should be experienced and capable of performing Bollywood, Retro, Contemporary, Fusion, and Alumni-requested numbers. A technical rehearsal shall be conducted prior to the event to ensure smooth functioning.
- 4. The quantities, sizes, and specifications of the sound system, stage setup, and other equipment mentioned in the tender/enquiry are approximate and indicative only. The exact requirements shall be finalized and communicated by IIITA in the Work Order issued to the selected agency. Further, the agency shall comply with the Technical Rider(s) of the Artists/Performers provided by IIITA for the Cultural Event to ensure proper stage, sound, and lighting arrangements. Any additional equipment or services required as per the approved Technical Rider(s) shall be arranged by the agency without delay and within the quoted rates, unless otherwise agreed in writing.
- 5. Vendors are desired to quote Artists performance fee separately.
- 6. Payment of Artists performance fee will be made at the time of completion of programme in form of Cheque/DD. Applicable TDS will be deducted.
- 7. **Logistics & Responsibility:** Agency shall be responsible for transportation, loading/unloading, setup, and dismantling of all instruments and equipment. Agency shall deploy adequate manpower, including sound engineers and technicians, for uninterrupted operation. A backup system must be kept ready to avoid disruption during the event.

- 8. Fuel Requirements to be borne by the firm only, no extra payments for fuel requirement would be done by the institute.
- 9. All the taxes should be mentioned in the quotation.
- 10. All prices should include transportation, labour and any service charge. No extra payment will be done for the same.
- 11. No payment will be made for the item whose specifications will not match with those mentioned in the final work order.
- 12. There could be more items other than those mentioned above.
- 13. The firm must complete the work within time as desired by the designated committee.
- 14. If the Inspection Committee found any delay, misconduct or deficiency of services, a fine will be imposed on the firm.
- 15. Quoted rates should be valid till the programme as scheduled.
- 16. The contract shall be issued to the successful bidder at least three (03) days prior to the date of the event. The successful bidder shall ensure provision of services strictly in accordance with the terms and conditions of the contract.
- 17. The contractor shall not sub-contract to any other party.
- 18. The hiring work, including delivery, installation, testing, and commissioning of equipment, as well as readiness of the live band and sound arrangements, must be completed within the scheduled time frame as communicated by IIITA. In case of any delay in supply or failure to adhere to the stipulated time schedule, a penalty of 1% of the total contract value per week of delay, subject to a maximum of 10% of the total contract value, may be imposed at the discretion of the Competent Authority of IIITA. The decision of IIITA regarding the imposition of penalty shall be final and binding on the agency.
- 19. All disputes are subject to the Jurisdiction of Hon'ble Allahabad High Court.
- 20. Director Indian Institute of Information Technology, Allahabad reserves the right to reject or accept any quotation
- 21. Director Indian Institute of Information Technology, Allahabad reserves the right to alter/modify any or all conditions of this quotation.


