2. Quoted rate should be valid at least for 45 days from the last date of submission of tender.
3. Tenderer should submit GSTIN registration copy with quotation.
4. It is mandatory to sign & stamp on all the papers of the tender/ enquiry letter.
5. Tenderers are desired to quote all the items as mentioned above, failing which quotation will not be considered.
6. Enquiry/tender must be quoted in prescribed format on the letter head of the firm/vendor, otherwise quotation shall be rejected outright.

Supply should be completed within 04 weeks from the receipt of the work order, If the work delayed beyond the stipulated time of completion penalty of 1% per week or part thereof of total cost shall be imposed at the discretion of Competent Authority.
