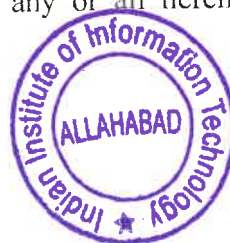

Incomplete quotation will not be accepted.**

2. Quoted rate should be valid at least for 45 days from the last date of submission of tender.
3. **All the compound target must be expressed in terms of their molecular composition (Molecular weight). (EDAX data required)**
4. **All Target must be supported by backing plates.**
5. Tenderer should submit GSTIN registration copy with quotation.
6. It is mandatory to sign & stamp on all the papers of the tender/enquiry letter.
7. Tenderers are desired to quote all the items as mentioned above, failing which quotation will not be considered.
