1 INSTRUCTIONS FOR ONLINE BID SUBMISSION

As per the directives of the Department of Expenditure, this tender document has been published on the Central Public Procurement Portal (URL: <http://eprocure.gov.in/eprocure/app>). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidder in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal. More information useful for submitting online bids on the CPP Portal may be obtained at <http://eprocure.gov.in/eprocure/app>.

1.1. REGISTRATION

- 1.1.1. Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: <http://eprocure.gov.in/eprocure/app>) by clicking on the link “Click here to Enroll”. Enrolment on the CPP Portal is free of charge.
- 1.1.2. As part of the enrolment process, the bidder will be required to choose a unique username and assign a password for their accounts.
- 1.1.3. Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal
- 1.1.4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra / Capricon etc.), with their profile.
- 1.1.5. Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 1.1.6. Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

1.2. SEARCHING FOR QUOTATION /TENDER DOCUMENTS

- 1.2.1. There are various search options built in the CPP Portal, to facilitate bidder to search active Tender by several parameters. These parameters could include tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tender, wherein the bidder may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- 1.2.2. Once the bidders have selected the tender they are interested in, they may download the required documents schedules. These tenders can be moved to the respective ‘My Tender’ folder. This would enable the CPP Portal to intimate the bidder through SMS / e-mail in case there is any corrigendum issued to the Tender document.
- 1.2.3. The bidder should make a note of the unique Tender ID assigned to each Tender in case they want to obtain any clarification / help from the Helpdesk.

1.3. PREPARATION OF BIDS

- 1.3.1. Bidders/Tenderers should take into account any corrigendum published on the Tender document before submitting their bids.
- 1.3.2. Please go through the Tender / Tender advertisement and the Tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the documents that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 1.3.3. Bidders, in advance, should get ready the bid documents to be submitted as indicated in the Quotation document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 1.3.4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidder. Bidder can use “My Space” area available to them to upload such documents. These documents may be directly



submitted from the “My Space” area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for the bid submission process.

1.4. **SUBMISSION OF BIDS**

- 1.4.1. Bidders/Contractor should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder/Contractor will be responsible for any delay due to other issues.
- 1.4.2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the Tender document.
- 1.4.3. A standard BOQ format has been provided with the Tender document to be filled by all the Bidders/Contractor. Bidders/Contractor are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BOQ file, open it and **complete the white colored (unprotected) cells** with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

OR

In some cases, Financial Bids can be submitted in RAR format as well (in lieu of BOQ).

- 1.4.4. The server time (which is displayed on the bidder’ dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidder, opening of bids etc. The bidder should follow this time during bid submission.
- 1.4.5. All the documents being submitted by the bidder would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done.
- 1.4.6. The uploaded Tender documents become readable only after the Tender opening by the authorized bid openers.
- 1.4.7. Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 1.4.8. Kindly add scanned PDF of all relevant documents in a single PDF file of the compliance sheet.

1.5. **ASSISTANCE TO BIDDER**

- 1.5.1. Any queries relating to the Tender document and the terms and conditions contained therein should be addressed to the Tender Inviting Authority for a Tender or the relevant contact person indicated in the Tender.

1.6. **GENERAL INSTRUCTIONS TO THE BIDDER**

- 1.6.1. The Tender will be received online through the portal <http://eprocure.gov.in/eprocure/app>. In the Technical Bids, the bidder is required to upload all the documents in .pdf format.
- 1.6.2. Possession of a Valid Class- III Digital Signature Certificate (DSC) in the form of smart card/e- token in the company's name is a prerequisite for registration and participating in the bid submission activities through <https://eprocure.gov.in/eprocure/app>. 2. INVITATION OF TENDER FOR SUPPLY, INSTALLATION, TESTING AND COMMISSIONING OF COMMERCIAL REVERSE OSMOSIS(RO) PLANT OF 500 LPH IN HOSTELS AT IIIT-A

Indian Institute of Information Technology, Allahabad invites online Bids (Technical bid and Commercial/Price bid) from eligible and experienced bidders for **Supply, Installation, Testing and Commissioning of Commercial Reverse Osmosis(RO) Plant of 500 LPH (5 Nos.) in Hostels at IIIT-A**

The scope shall include Supply, Installation, Testing and Commissioning (SITC) of complete, standalone 500 LPH Commercial Reverse Osmosis (RO) Based Drinking Water Treatment System at the designated Hostel Building(s) of IIIT-Allahabad, including all necessary pretreatment, RO membrane system, post-treatment, UV sterilization, treated-water storage, piping, electrical/control system, SS304 skid/frame, supports, fittings, valves, instrumentation, testing, commissioning and all other accessories required for satisfactory operation.

The work shall be executed on a complete turnkey basis, and any component/accessory required for successful operation, even if not specifically mentioned in the BOQ, shall be deemed included in the bidder's scope without any additional financial implication to the Institute.

3. TECHNICAL SPECIFICATIONS

Sr. No.	DESCRIPTION OF WORK
1	<u>Capacity and Performance</u> a. The RO plant shall have a minimum rated capacity of 500 Litres Per Hour (LPH) of treated/purified water. b. The system shall be suitable for continuous institutional drinking-water requirements of the hostel. c. The bidder shall guarantee the rated permeate production of 500 LPH under the actual site conditions and design parameters established through raw-water analysis. d. The RO system shall be designed to achieve treated-water TDS below 100 ppm , subject to the raw-water characteristics and proper operation/maintenance of the system. e. The bidder shall submit the proposed system design, recovery ratio, membrane configuration, operating pressure and expected permeate quality along with the technical offer.
2	<u>SS304 Construction</u> a. The complete RO system shall be mounted on a robust, factory-fabricated SS304 skid/frame suitable for continuous institutional operation. b. All exposed structural/support members forming part of the RO skid shall be of SS304 grade stainless steel . c. The bidder shall ensure that the skid/frame is adequately designed to withstand operating loads, vibration and site conditions. d. Necessary rooftop supports, clamps, mounting arrangements and vibration-isolation arrangements shall be included in the scope of work.
3	<u>Raw Water Analysis and Design Basis</u> a. The successful bidder shall conduct a comprehensive raw-water quality analysis before finalizing the RO system design. b. The analysis shall include, at minimum, TDS, pH, hardness, alkalinity, turbidity, iron, chloride and other parameters relevant to RO system design.



	c. Based on the analysis, the bidder shall submit a Design Basis Report (DBR) indicating the proposed pretreatment arrangement, membrane configuration, recovery, expected permeate quality and operating parameters. d. The RO system and pretreatment arrangement shall be finalized based on the actual raw-water characteristics at the Institute.
4	<u>Pre-treatment System</u> The system shall include suitable pretreatment as required based on raw-water analysis. The pretreatment shall include, as applicable: ● Raw-water filtration; ● Multimedia/pressure sand filtration; ● Activated carbon filtration; ● Micron cartridge filtration; ● Antiscalant dosing, wherever required; ● Any additional pretreatment required for protection and satisfactory performance of RO membranes. The bidder shall be responsible for selecting and sizing the pretreatment system based on the actual raw-water characteristics.
5	<u>RO Membrane System</u> a. The RO membrane system shall be designed for commercial/institutional continuous operation. b. RO membranes shall be of reputed OEM make and suitable for the proposed feed-water characteristics. c. The system shall incorporate suitable high-pressure pump(s), pressure gauges, flow measurement and necessary control/safety devices. d. Automatic membrane flushing arrangement shall be provided to minimize scaling and biofouling. e. The RO system shall be capable of maintaining the specified treated-water quality under normal operating conditions.
6	<u>Post-Treatment and Disinfection</u> a. The treated water shall pass through suitable post-treatment filtration and UV sterilization before entering the treated-water storage system. b. The UV system shall be adequately sized for the rated flow of the RO plant. c. UV lamp status/effectiveness indication shall be provided wherever applicable. d. The complete treated-water distribution system shall be properly flushed and disinfected before commissioning.
7	<u>Treated Water Quality</u> a. The treated water shall have TDS less than 100 ppm under normal operating conditions. b. The treated water shall conform to applicable BIS drinking-water requirements and other applicable statutory requirements. c. The vendor shall demonstrate the treated-water quality during commissioning through testing from an appropriate laboratory, if required by the Institute. d. During the warranty/AMC period, periodic treated-water quality testing, including microbiological parameters, shall be carried out as directed by the Institute.
8	<u>Treated Water Storage and Distribution</u> a. Treated water shall be collected in a suitable food-grade HDPE storage tank of adequate capacity. b. The storage tank shall be suitably sized for the hostel's drinking-water requirement and site conditions. c. The treated water shall be distributed through suitable food-grade piping to the designated drinking-water points.



	d. Necessary valves, fittings, supports, clamps, pipe connections and other accessories shall be included in the bidder's scope. e. The system shall be designed to ensure adequate water pressure/flow at all designated drinking-water points. f. Zero Wastage of Water(Waste water put on nearest washroom water tank)
9	<u>Electrical and Automation Requirements</u> The system shall include, as a minimum: ● Automatic level control; ● Float valve/level switch; ● Dry-run protection; ● High-level overflow cut-off protection; ● Automatic membrane flushing; ● Feed, permeate and reject pressure gauges; ● Suitable flow indicators/meters; ● Fault indication; ● Suitable control panel with necessary protections; ● Proper earthing and internal cabling. All electrical works from the designated power-supply point to the RO system shall be in the bidder's scope.

4. SPECIAL CONDITIONS OF CONTRACT

4.1. These instructions are over and above the instructions contained in the enclosed set of tender documents and **override** instructions in case of conflict.

4.2. Warranty

4.2.1. The complete RO system shall carry a minimum one-year comprehensive warranty from the date of successful commissioning.

4.2.2. The warranty shall cover the complete system, including RO unit, pumps, UV system, electrical/control system, distribution system, leakage rectification and workmanship defects.

4.2.3. Any defect/complaint during the warranty period shall be attended to within 48 hours of notification.

4.2.4. In case of critical breakdown affecting drinking-water supply to hostel residents, immediate response shall be provided.

4.3. Comprehensive AMC

4.3.1. The bidder shall quote Comprehensive AMC charges separately for a minimum period of five years after expiry of the standard warranty period.

4.3.2. The AMC shall include preventive maintenance, membrane cleaning, sanitization, inspection, routine consumables, replacement of defective parts and servicing of pumps and electrical systems.

4.3.3. Periodic treated-water quality testing, including microbiological parameters, shall be carried out during the AMC period as directed by the Institute.

4.4. Consumables and Replacement



All filters, cartridges, RO membranes, UV lamps, antiscalant chemicals and other consumables required to maintain the specified system performance shall be replaced as per OEM recommendations or earlier, if required.

During the warranty/AMC period, such replacements shall be included in the comprehensive scope wherever specified under the contract. The existing specification provides for periodic replacement of micron cartridge filters, antiscalant replenishment, UV lamps and RO membranes as required to maintain performance.

4.5. Breakdown Response

- 4.5.1. Any complaint regarding non-functioning of the RO plant/distribution system during the warranty/AMC period shall be attended to promptly.
 - 4.5.2. The breakdown shall be rectified within 48 hours of reporting.
 - 4.5.3. In case of critical breakdown affecting drinking-water supply, immediate response shall be provided.
 - 4.5.4. The vendor shall provide an escalation matrix containing contact details of the Site Engineer, Regional Manager and Head Office for unresolved complaints.
- 4.6. Vendor shall provide an escalation matrix with contact details at three levels (Site Engineer, Regional Manager, Head Office) for breakdown complaints not resolved within 72 hours.

4.7. Penalty Clause

Event	Penalty
Delay in Installation/Commissioning beyond 45 days from the date of Work Order	Rs. 5,000/- per day for the period of delay beyond the stipulated 45 days.
Failure to maintain treated-water TDS below 100 ppm / specified water-quality parameters	Vendor shall rectify the deficiency within 48 hours of written notice. Failing rectification, Rs. 10,000/- per instance may be imposed.
Breakdown not rectified within 72 hours	Rs. 5,000/- per day shall be imposed for the period beyond the stipulated response/rectification period until the system is restored.

Installation of any substandard, non-OEM, or unauthorized device/part shall attract a minimum penalty of ₹10,000 per instance.

4.8. Training

The vendor shall provide at least one-day operational training to designated Institute personnel covering routine operation, preventive maintenance, basic troubleshooting, safety and breakdown-response procedures.

- 4.9. No additional payment shall be made for any item/accessory necessary for successful installation, commissioning and operation but inadvertently omitted from the BOQ.
- 4.10. The vendor shall comply with applicable BIS standards, statutory requirements and OEM recommendations.
- 4.11. The final acceptance of the system shall be subject to successful commissioning, satisfactory trial operation and demonstration of the specified treated-water quality and system performance.



4.12. Timely Completion

- 4.12.1. The work included in this tender is urgent. Therefore, all work components must be started simultaneously and has to be delivered together or early within the given time schedule.
- 4.12.2. Number of days from the date of issue of letter of acceptance for reckoning date of start shall be as per Schedule. *If the Contractor commits default in commencing the execution of the work as aforesaid, the performance guarantee shall be forfeited.*
- 4.12.3. The contractor shall procure the required materials in advance so that there is sufficient time for testing of the materials and approval of the same before use in the work, as required.

4.13. Rates

- 4.13.1. Unless otherwise provided in the schedule of quantities of the work the rates tendered by the contractor shall be all inclusive and nothing extra shall be payable to him on this account.
- 4.13.2. The rates for all items of work shall, unless clearly specified otherwise, include cost of all labours, materials and other inputs involved in the execution of the work irrespective of whether they have been specifically mentioned in the tender document or not.
- 4.13.3. In case the same item (s) appear more than once in the schedule of work /BOQ under the same sub head or among the different subhead of works, the lowest rate quoted for that item(s) shall be considered for the particular item(s) wherever appeared in any part of BOQ/Schedule of works for the purpose of tender evaluation although web generated e-price bid may incorporate different quoted rate for same item(s) as per the quoting pattern of the tenderer. The tendered amount thus worked out shall be final & shall be binding on the contractor.
- 4.13.4. The rates quoted by the contractor will be deemed to be inclusive of any extra expenditure of this reason. The contractor has to increase the manpower or other tools etc. to do the work as per the quantum of work provided to him at his own expenses. Nothing shall be paid on this account.
- 4.13.5. All material shall only be brought at site as per program finalized with the Engineer-in- Charge. Any pre-delivery of the material not required for immediate consumption shall not be accepted and thus not paid for.
- 4.13.6. The rates quoted by the Contractor are deemed to be inclusive of site clearance, setting out work, profile, establishment of reference bench mark(s), taking spot levels, construction of all safety and protection devices, barriers, preparatory works, working during monsoon until /unless specified otherwise and any other incidental works required to complete this work. Nothing extra shall be payable on this account.

4.14. Quality and Ownership

- 4.14.1. The contractor shall be entirely responsible and answerable for all the works done by him regarding quality, adherence to the laid down specifications, terms and conditions, warranty/guarantee etc. and he shall be liable to bear any compensation that may be levied by the department under any of the clauses of the agreement.
- 4.14.2. The materials having ISI mark shall have precedence over the one conforming to IS Specifications.
- 4.14.3. The contractor shall have to engage well experienced skilled labour and other equipment to execute the work.
- 4.14.4. Samples of all materials to be used in the work shall be approved from the Engineer-in-Charge in writing, well in advance of actual execution and shall be preserved till the completion of the work.
- 4.14.5. The department may ask for any valid document like manufacturer's test certificate, document for purchase of the material, document for import/shipment of imported materials etc. as deemed fit by



the engineer-in-charge to ascertain genuinely of material supplied by/used in the work by the contractor. The contractor shall remain bound to submit all such documents to the department failing which payment may not be made or if already paid may be recovered/ withheld from subsequent running account payment.

- 4.14.6. All equipment and their components, and all the materials to be used in the work shall be suitable for the environmental conditions at the location of the work.
 - 4.14.7. The contractor shall ensure quality control measures on different aspects and shall have to submit a quality assurance programme within two weeks of the award of work. The quality assurance programme should include method statements for various items of work to be executed along with check lists to enforce quality control.
 - 4.14.8. The contractor shall ensure quality work in a planned and time bound manner. Any sub-standard material/work beyond set out tolerance limit shall be summarily rejected by the Engineer-in-Charge.
- 4.15. Stocking and Disposal of Materials and Debris**
- 4.15.1. The contractor shall take instructions from the Engineer-in-Charge regarding collection and stacking of materials at any place.
 - 4.15.2. After completion of work the agency shall remove materials and debris etc. from site and shall be disposed off at any suitable place as per the direction of Engineer-in-Charge, at no extra cost.
- 4.16. Safety and Security**
- 4.16.1. The contractor shall be fully responsible for the safe custody of materials brought by him/ issued to him even though the materials may be under double lock key system.
 - 4.16.2. The Contractor will arrange proper machinery and equipment at his own cost and will take all safety measures like using safety gadgets during work. If it is observed that work is proceeding without adequate safety precautions, work may be stopped by Engineer-in-charge and in such cases, contractor will be solely responsible for delay and its consequences thereof.
 - 4.16.3. All the machineries involved in the work shall have valid certifications and proper registrations.
 - 4.16.4. The contractor shall take all precautions to avoid accidents by exhibiting necessary caution boards day and night speed limit boards, red flags, red lights and providing barriers. He shall be responsible for all dangers and incidents caused to existing / new work due to negligence on his part
 - 4.16.5. It shall be ensured by the contractor that no electric live wire is left exposed or unattended to avoid any accidents in this regard.
 - 4.16.6. The Institute shall not have any responsibility or liability in case of any accident injury to the personnel to the contractor at worksite or to the general public at the work site due to mishandling equipment by the personnel of the contractor or any other similar reason. The responsibilities and liabilities for such accidents and incidents shall be borne by the contractor.
- 4.17. Act and laws**
- 4.17.1. The Contractor shall keep himself fully informed of all acts and laws of the Central & State Governments, all orders, decrees of statutory bodies, tribunals having any jurisdiction or authority, which in any manner may affect those engaged or employed and anything related to carrying out the work. All the rules & regulations and bye-laws laid down by Collector/MC etc. and any other statutory bodies shall be adhered to, by the contractor, during the execution of work.
 - 4.17.2. All statutory taxes, levies, charges (including water and sewerage charges, charges for temporary service connections and/ or any other charges, as applicable) payable to such authorities for carrying out the work, shall be borne by the Contractor.
 - 4.17.3. The Contractor shall arrange to give all notices as required by any statutory/ regulatory authority and shall pay to such authority all the fees that are required to be paid for the execution of work. He shall



protect and indemnify the Institute and its officials & employees against any claim and /or liability arising out of violations of any such laws, ordinances, orders, decrees, by himself/ herself or by his/her employees or his/her authorized representatives. Nothing extra shall be payable on these accounts.

4.18. **Labour and Laws**

- 4.18.1. The Contractor may display all permissions, licenses, registration certificates, bar charts, other statements etc. under various labour laws and other regulations applicable to the works, at his site office.
- 4.18.2. Huts for labour are not permitted within the premises of the Institute. No extra cost shall be payable even if the contractor provides such accommodation at a place as is acceptable to the local body.
- 4.19. **One bid per bidder:** - Each Bidder shall submit only one Bid, either individually or as a partner in a joint venture. A Bidder who submits or participates in more than one Bid (other than as a sub -contractor) shall cause all Bids with the Bidder's participation to be disqualified.
- 4.20. **Pre bid Qualification:** Any pre-bid clarifications if required, then same may be obtained online through the tender site, or through the contact details given in the tender document.
- 4.21. **Order of Acceptance:** -Successful bidder should submit Order Acceptance within 7 days from the date of order.
- 4.22. **Rate Quoted:** The currency of all quoted rates shall be Indian Rupees. All payment shall be made in Indian Rupees. The rates are to be quoted by the bidders in Indian Rupees only and payment shall be made to successful bidders in Indian Rupees only. Any statutory applicable taxes such as applicable Tax, etc. should be mentioned separately in the Financial Bid. However, quotes should be inclusive of all other levies, statutory taxes and charges etc and should be delivered at the premises. All prices shall be fixed and shall not be subject to escalation of any description. The rates must be quoted strictly as per the 'Financial Bid Format' provided.
- 4.23. **Before starting the work sample & brand should be approved by the Institute authority. However, Contractor/vendor is required to purchase the required material only from authorized dealer/ Re-seller.**
- 4.24. **Quantity :** The mentioned quantity in the bill of quantity may be vary $\pm 25.0\%$
- 4.25. **Deviation on Tendered Amount:** Deviation should be as per CPWD Work manual 2023 Clause No. 12.
- 4.26. **Extension in Delivery and Completion of Work:** The time of delivery and Completion of Work and handing over in satisfactory condition and as per the schedule is the essence of the contract. Delivery of completion of Work is delayed for reasons of force majeure such as acts of God, Acts of Public enemy, acts of Government, fires, floods, epidemics, quarantine restrictions, illegal strikes and freight embargoes, the Contractor shall give notice to IIIT Allahabad in writing within 3 days from the date of such occurrence or happening of the events causing delay on the prescribed forms i.e. Form of application by the contractor for seeking extension of time (Appendix -IX) respectively to the authority of his claim for extension of delivery period. IIIT Allahabad on receipt of such notice may agree to extend the supply/contract delivery date as may be reasonable but without prejudice to other terms and conditions of the contract. Such extension shall be communicated to the Contractor in writing, within 10 days of the date of receipt of such request from the Contractor. Unless the extended delivery period is agreed by IIIT Allahabad in writing, Tenderer cannot claim the extension of delivery time as a matter of right. IIIT Allahabad shall have the right to cancel/ extend the order validity/ levy Liquidated Damage (LD) as appropriate.
- In the event of partial work done by the agency, IIIT Allahabad shall withhold the entire payment until the whole of the work is completed as per the order.
- 4.27. **Performance Security :** The L1 bidder must submit an irrevocable performance security of @ 5 % of total values of work within 15 days of contract award for the due and faithful performance of the contract along with the other terms and conditions agreed to, valid for a minimum period of sixty days beyond the date of completion of all contractual obligations. Any payment to the bidder will be released only after submission of PS by the bidder. Extension of time for submission of PS beyond 15 days and up to the



date of submission of PS from the date of issue of contract may be given by the Competent Authority. However, a penal interest of 12% per annum of the amount of PS, or part thereof, shall be charged for the delay beyond 15 days, i.e., 15+1st day after the date of issue of contract. The interest on the delayed period shall be calculated on a pro rata basis for the number of delayed days. The amount shall be recovered from any payment due or become due against bills / any other amount lying with IIIT-A. The delayed submission of PS by the bidder shall be recorded in substantial completion and final completion certificates. If contractor fails to submit the PS within 60-days from the date of issue of contract, then following actions may be taken against such bidder:

- I. The bidder shall be debarred/ banned from participating in the business dealings with IIIT-A for a period of two years.
- II. The name of the bidder shall be hosted on the IIIT-A website etc. as per existing norms of IIIT-A/ Govt. of India.
- III. Such defaulted bidder shall not be eligible to participate in the bidding process of re-tender of this bid.
- IV. Award shall be summarily terminated.
- V. EMD/Bid security shall be forfeited.

- 4.28. **Completion period:** Work should be completed within **08 weeks** from the date of agreement and after site clearance. If, the work delayed beyond the stipulated time of completion penalty of 1% per month or part thereof of total cost shall be imposed at the discretion of competent authority. The penalty may be upto 10% of the total accepted bid value. This purchase/Work order will be automatically expired after **08 weeks** unless extension is provided by the Institute on request by the bidder.
- 4.29. **Forfeiture of bid security:** Bid security of a tenderer will be forfeited, if the tenderer withdraws or amends its tender or depreciates from the tender in any respect within the period of validity of its tender. Further, if the successful tenderer fails to furnish the required performance security within the specified period, its bid security will be forfeited.
- 4.30. **Completion of Work:** Before finally leaving the site, all the Bidders stores, plant, tools and rubbish shall be removed and the site left clean and tidy. The space allocated by Owner shall be vacated and handed over to the Owner.
- 4.31. **Working and Safety Regulations:** The bidder shall observe all statutory safety and legal requirements regulations issued by Central and State Governments applicable to the work as well as any local regulations applicable to the site issued by the Owner or any other authority.
- 4.32. **Setting out Works:** The bidder shall set out the works and responsible for the true and perfect setting out of the same and for the correctness of the positions, levels, dimensions and alignment of all parts thereof, if at any time any error shall appear during the progress of any part of works the bidder shall at his own expenses rectify such error, to the satisfaction of the Engineer In-charge.
- 4.33. All the work will be executed as per site condition under the instruction of the Engineer In-charge. If any other work will require to be undertaken related to this work or any alteration in work, will be executed on the basis of approved rates after prior approval.
- 4.34. **Payment:**
- 4.34.1. Agency can raise the running bill as per progress of work. Accordingly, the payment will be made after verification by the engineer in charge up to 2nd & final bill.
 - 4.34.2. At the time of forwarding any bill for payment, Engineer In-charge should ensure that all the terms and conditions of the tender documents have been fulfilled and deduction if any have been proposed.
 - 4.34.3. Applicable TDS and other deductions as per provisions will be recovered (deducted) from the payment(s).
 - 4.34.4. Water Charges @ 1% of the executed amount and electricity charges as per load or on the basis of actual reading (if meter has been installed) will be deducted from the bill of the agency. If agency will arrange their own arrangement of water & Electricity charge will not be recovered from the agency bill.
 - 4.34.5. Labour welfare cess as per prevailing rate has to be deposited by the contractor and should submit for the records.



4.35. **Penalty for delay in work:**

- 4.35.1. With maximum rate @ 1% (one percent) maximum per month of delay to be computed on a per day basis based on the quantum of damage suffered due to stated delay on the part of the Contractor.
- 4.35.2. Provided always that the total amount of compensation for delay to be paid under this condition shall not exceed 10 % of the accepted Tendered Value of work
- 4.35.3. Other penalties will be imposed as per the work carried out by the contractor as per Clause 2 of GCC-2023 construction Work.
- 4.35.4. In such case(s) the Contractor/Bidder should notify and produce / bring the relevant communication and proof to IIITA promptly of any failure to perform or delay in performing due to any of the above reasons for the penalty to be waived off.

4.36. **Price Basis and applicable Tax claim:** Vendor should clearly mention the Rate of applicable GST separately, if firm will not mention the Taxes clearly on their Price Quotation, IIIT - Allahabad will assume that the quoted price is inclusive of all and no extra amount in later stage shall be paid by IIIT, Allahabad on account of Taxes. In case of tax exemption or lower TDS, the vendor has to submit a letter from the Government Authority for tax exemption or lower TDS (to be submitted along with each of the invoice(s). If the Tenderer/Bidder has opted for composition scheme under GST ACT 2017, they have to declare themselves as "Composition Scheme" in the bid and indicate their Registration number in the Price Bid. Bidder shall have to enclose a certificate in original from a practicing Chartered Accountant/Cost & Management Accountant/Company Secretary confirming that Bidder is eligible to opt the scheme and has fulfilled all the conditions as mentioned in notification in this regard. In addition, the Tenderer/bidder has to enclose the self-attested GST Registration Certificate in the commercial bid. If the Bidder is unregistered i.e. exempted from GST registration, they have to declare themselves as "GST Unregistered Bidders" in the bid and shall have to enclose GST Exemption documents i.e. certificate in original from Practicing Chartered Accountant/Cost & Management Accountant/Company Secretary that Bidder is fulfilling all the conditions prescribed in GST Act, 2017 to make him exempt from registration.

4.37. If it is found that items are fake or of sub-standard quality and not conforming to the required specifications, the firm will have to replace the fake/ sub-standard items with genuine ones immediately but they will also be liable to be blacklisted.

4.38. If the work carried out by the bidder is not found acceptable, IIIT Allahabad has the complete right to reject the same without giving any compensation.

4.39. **Force Majeure:** The vendor (bidder) will not be held responsible for breach of executing any obligation or delay in executing any obligations during below given circumstances / conditions.

4.39.1. War, Riots, Strike, Fire, Flood, Earthquake, Storm, Epidemic breakout, Power failure, Theft etc.

4.39.2. Any Governmental priorities (Necessary proof for validation viz. Govt. Gazette notifications, Leading Newspaper reports, etc. should be made available).

4.40. Rates quoted by the firm should not be higher than the prevailing market rate.

4.41. **Dispute Resolution:** In the event of any dispute arising out of or in connection with this Order, the parties shall use their best endeavor to resolve the same amicably and if the dispute could not be settled amicably, the matter shall be settled in the court under Prayagraj (Allahabad) jurisdiction only. The final payment will be released only after the vendor (bidder) complies with the above-mentioned clause.

4.42. **Right to alter Tender:**

4.42.1. IIITA reserves the right to alter the Tender terms and conditions at any time before submission of the bids.

4.42.2. IIITA reserves the right to modify, amend, alter (Partially or Fully) and/or cancel/reject the entire RFP at any stage without assigning any reason whatsoever. IIITA's decision in this regard will be final and binding on all vendors (bidders).

4.43. Conditional quotations are liable to be rejected. In the event of acceptance, the Director's decision will be final. The rates should be quoted as per our required specifications.

4.44. The rates should be quoted in Indian rupees. As per our BOQ.

4.45. The right to accept or reject any tender/ quotation, partially or wholly, including lowest quotation without assigning any reason whatsoever thereof or incurring any liability thereby is reserved with the Director,



IIIT, Allahabad. The Director, also reserves the right to split the tender and place the orders for supply of item(s), mentioned in the enquiry letter on one or more tenderer. The decision of the Director, with regard to enforcement of these terms and conditions herein contained, as a result of breach of these conditions by successful Tenderer/s, shall be final and the Director, shall not be liable for any damage/liability put forth by the Tenderers at any stage of the transaction arising out of the enforcement of any or all herein contained terms and conditions.

- 4.46. All the documents submitted must be legible and self-attested and stamped. Otherwise it is likely to be rejected.
- 4.47. The Bid Security shall be returned to the bidder(s) whose offer is not accepted by the Institute within 15 days after finalization and award of the contract without any interest. Unsuccessful bidders may collect the Bid Security (within next 10 days after finalization & award of the contract) from Purchase Section, IIIT-A between 3:00 PM and 5:00 PM on any working day after providing a copy of authorization letter and any Photo Identity Card. After these 10 days Bid Security will be sent by registered post to the postal address provided by the firm/bidder as mentioned in the tender document. Representatives may also collect the EMD on behalf of the bidder, after providing an authorization letter from the bidder along with a copy of his photo identity card. If the return of Bid Security is delayed for any reason, no interest/penalty shall be payable to the bidder.
- 4.48. Complete Postal address of tenderer/ bidder along with Email ID and mobile number (to dispatch the Bid Security to unsuccessful bidder).
- 4.49. Tenderers/Bidders responding to this enquiry shall be deemed to be agreeable to the terms and conditions herein contained. These terms and conditions shall be binding on the part of the successful tenderer. Tenders must be quoted in prescribed format on the company/firm letter head.
- 4.50. Quotation should be addressed to DeputyRegistrar(Stores & Purchase), Indian Institute of Information Technology, Deoghat, Jhalwa, Prayagraj-211015 (U.P.) India.
- 4.51. All the work will be executed as norm and specification of CPWD and as specified in bill of quantity. If any other work will require to be undertaken related to this work or any alteration in work, will be executed on the basis of approved rates after prior approval.

5. GENERAL CONDITIONS OF CONTRACT

- 5.1. Bidder must fill the Letter of Undertaking (**Annexure-IV**) and Declaration Proforma (**Annexure-V**) complete in all respect.
- 5.2. Bidder must quote their rates exclusive of all taxes and duties. Taxes applicable may be quoted separately giving full details.
- 5.3. **Bidders can visit the site before the due date of Tender. (During Working hour).For any further clarification, you may contact Junior Engineer (Electrical), IWD Section.**
- 5.4. Inspection of completed works by the designated Institute engineer will be done before final bill payment.
- 5.5. Bidders may please note that the received bids having matching/common IP address with either Bidder(s)/Seller(s) shall be outrightly rejected & shall not be considered for further evaluation.
- 5.6. "The Contract" means the agreement entered into between the Owner and the Bidder, as recorded in the contract form signed by the parties, including all the attachments and appendices there to and all documents incorporated by reference therein.
- 5.7. "The Contract Value" means the amount payable to the Bidder under the contract for the full and proper performance of its contractual obligations.
- 5.8. "The Work" means all labour, materials, tools and plants, equipment including government taxes and transport, that may be required in preparation of and for and in the full and entire execution and completion of "the Work".
- 5.9. "Services" means services ancillary to the execution of the work such as transportation and insurance, and any other incidental services, such as installation, commissioning, provision of technical assistance, training and other obligations of the Bidder covered under the contract.



- 5.10. For the Bidding/ Tender Document Purposes, Indian Institute of Information Technology, Allahabad shall be referred to as 'Institute' and the Bidder/ Successful Bidder shall be referred to as 'Contractor and / or Bidder or Tenderer / Supplier/ Vendor'.
- 5.11. While all efforts have been made to avoid errors in the drafting of the tender documents, the Bidder is advised to check the same carefully. No claim on account of any errors detected in the tender documents shall be entertained.
- 5.12. All Bidders are hereby explicitly informed that conditional offers or offers with deviations from the conditions of Contract, the bids not meeting the minimum eligibility criteria, Technical Bids not accompanied with Bid Security receipt of RTGS/NEFT of requisite amount or the proof of exemption from Bid Security and an Undertaking In lieu of Bid Security, or any other requirements stipulated in the tender documents are liable to be rejected.
- 5.13. The Bid Security shall be returned through electronic transfer if submitted online to the bidder(s) bank account as provided by the bidder(s) or it will be returned by post whose offer is not accepted by the Institute within 15 days after finalization and award of the contract without any interest. If the return of Bid Security is delayed for any reason, no interest/penalty shall be payable to the bidder.
- 5.14. **Debarment / Blacklisting** : The bidder should not be debarred, blacklisted, banned, suspended, or otherwise prohibited from participating in procurement by any Central Government Ministry/Department, State Government, PSU, Autonomous Body, or any other Government organization as on the last date of submission of bids.
