ITEM NO.5: To consider and approve the Academic Calendar of the Institute for the academic session 2018-19

With the coming in force of the New Ordinances for UG and PG Students enrolled at the Institute w.e.f. July 2018, the Institute has put in place a mechanism of the Continuous and Choice Based Credit System. While the detailed merits of the same shall once again be briefed to the members by the Chairman Senate in the meeting, the Academic Calendar in line with the new assessment mechanism has also been put in place, which is reflected in the tailor made Academic Calendar which was prepared by a designated committee.

For the students of batches admitted prior to the current academic session, the earlier ordinances will continue to be applicable upon them and a separate academic calendar for them.

The Senate approved the Academic Calendar as proposed for the Academic Session 2018-19.

ITEM NO. 6: To consider and approve the appointments of renowned faculty as Adjunct Faculty/Mentoring Faculty at IIIT Allahabad

The Item was approved.

ITEM NO. 7: To consider the proposal to establish a Centre for Short Term Certification Programmes on topics of excellence in Information Technology and allied areas

The Senate approved the proposal of establishing CSTCP with following additional requirements and provisions:

- 1) The administrative skill development certification programmes could also be offered through CSTCP.
- 2) The CSTCP should prepare an annual calendar and follow it.
- 3) The Courses for which credits are to be awarded must approved by the Senate. Such courses may also be included in the list of courses for credit transfer policy. Specialized courses for mass education to some specific audience may also be designed, however, these should be offered in the vacation period.
- 4) A Committee should be in place to ensure the quality of the contents of the courses and quality of assessment and certification.
