Agenda Item No. 25.01(a) To consider and ratify the date of XVII Convocation along with the name of Chief Guest for the XVII Convocation of the Institute.

The Senate resolved to ratify with pleasure to organise the XVII Convocation 2023 of the Institute on 18th March 2023 and also endorsed and ratified the name of Dr Sriram Rajamani, Managing Director, Microsoft Research India, as the Chief Guest on the occasion.

Agenda Item No. 25.01(b) To consider and ratify the content of the degree format arising due to difference in degree completion year and convocation year for all programs running in the institute.

The Senate resolved to ratify the approval on the modified contents of the Degree Formats, granted earlier by circulation through email.

Agenda Item No. 25.01(c) To consider and ratify the Hindi names for the following Programs:

- 2) M.Tech. IT Robotics and Machine Intelligence

The Senate resolved to ratify the approval on the Hindi Names of various Degrees, granted earlier by circulation through email.

The Senate noted the Statistics presented and resolved to approve the same in respect of the numbers of students Graduating out of the Institute during the XVII Convocation 2023.

Agenda Item No. 25.03 To consider and approve the names of Graduands for the award of various Medals and Merit Certificates to be awarded by the Institute on the occasion of the XVII Convocation scheduled to be held on 18-03-2023

The Senate considered the names of various Graduands who had qualified for award of various Institute Medals, Endowment Medals as well as Merit Certificates, and resolved to approve the same.

In respect of the award of Merit Certificates exclusively to MTech-PhD Graduands, the Senate resolved to constitute a committee to examine the policy in this matter and provide its recommendations to the Chairman Senate. Based upon the recommendations of this Committee the Senate authorized the Chairman Senate to declare the names of eligible Merit Certificate Awardees, if any, before XVII Convocation. The Committee for the purpose would comprise of – Dean Academics (Chairman), Prof U S Tiwary, Prof Shekhar Verma, Prof Pavan Chakraborty, Chairman SPGC.

Agenda Item No. 25.04 To consider and approve the names of Graduands who are due to get their Degrees for various Programs in the XVII Convocation of the Institute to be held on 18-03-2023
