





**R. No. B-27.08-(B):** The BoG further RESOLVED to mandate the Institute on articulating and adhering to the reservation roster cadre-wise i.e. Assistant Professor Grade (I), Assistant Professors Grade (II) Associate Professor, and Professor levels as per relevant G.O.I rules and CEI Act 2019.

However to honor the true spirit of Flexi Faculty cadre structure as applicable to IIIT Allahabad, the BoG further APPROVED to empower the Director to review and redefine the number of faculty positions at each grade/level with the prior approval of the BoG, time to time, so that updated reservation roster shall be prepared for such changed numbers and adhered to by the Institute, before initiation of each iteration of faculty recruitments.

The BoG further APPROVED to empower the Director to study the concerned practices of other CF-IIITs and adopt them amicably for smooth conduct of prospective rounds of recruitments.

**R. No. B-27.08-(C):** The BoG further suggested that the Schedule (E) of the NIT Act be studied in breadth and depth by the Institute's administration towards its possible adoption at appropriate levels.

**R. No. B-27.08-(D):** The BoG further ADVISED the Director to proceed for recruitment rounds in multiple phases by considering the newly created faculty positions, in coordination with the Ministry and other statutory authorities.

With the permission of the Chairperson BoG the following four items viz. SI, SII, SIII, and SIV (annexed herewith), were taken up by the BoG.

The BoG was informed about the two recent FIRs vide FIR No. 0035 and FIR No. 0029 logged u/s 154 Cr.P.C. through **Agenda 27.13.SI and 27.13.SII**.

**FIR No. 0035:** The 6<sup>th</sup> Inter IIITs Sports Meet 2024 was organized at IIIT Allahabad from 9-12 March 2024, where 21 IIITs participated from all over the country. On 9<sup>th</sup> March around 02:20 P.M. one of the participants from IIITDM Jabalpur was injured in his right thigh with a deep wound and was taken to the Swaroop Rani Medical College Prayagraj, where the doctors reportedly said it was a bullet injury. The matter was reported to the Prayagraj Airport Police Station on 10.03.2024 and the Police have registered the First Information Report u/s 154 Cr.P.C. vide FIR No. 0035

**FIR No. 0029:** On 14.01.2024, an email was received by Mr. Joginder alias Deep Prakash regarding concocted allegations against IIIT Allahabad and Ministry. In the above email, many baseless allegations regarding irregularities, etc. were mentioned without any proof. Mr. Joginder has also mentioned objectionable, indecent, and appropriate remarks against lady teachers and senior authorities/officers. The matter was reported to the Prayagraj Airport Police Station on 29.02.2024 and the Police have registered the First Information Report u/s 154 Cr.P.C. vide FIR No. 0029.


The BoG perused the same.

Additional **Agenda Item SIII** was related to increasing the number of PhD fellowships per faculty across various departments of IIIT Allahabad. After hearing to the submission by Prof. Shekhar Verma, the Board decided as follows:

**R. No. B-27.13.SIII:** On the issue of increasing the number of PhD positions (per faculty) with fellowships from Ministry's Block grant, under appropriate head of expenditure, the BoG DECIDED to defer the item and advised to put-up the same, with more details, in the next meeting.

Additional **Agenda Item SIV** was related to the reduction of tuition fees for various PG and PhD programs, on par with other Institutes of National Importance. After hearing to the Director on such parallel fee structures in other CFTIs, and with an intent to attract

the better-quality candidates, with larger numbers, to the PG and Research programs, the BoG decided as follows:

**R. No. B-27.13.SIV:** On the issue of reducing the tuition fees for PG and PhD programs, the BoG, in-principle, APPROVED to reduce the semester fees for M.Tech and PhD students of IIIT Allahabad, and to make them consistent with the other CFTI IIITs. The reduction in fee with the new fee structure for M.Tech and PhD students shall be routed through Finance Committee of the Institute.
