### **WHO CAN ATTEND?**

1. Graduates/Post Graduates/ PhD. Scholars from Engineering/MBA background, having skillset in Information Technologies (Also students appearing in final year of their Graduation/ Post Graduation & PhD. can also apply).
2. Engineering Graduates/Post Graduates who have been granted any seed money for their startup proposal from any Academic Institute/Organization/Government/Semi-Government would be preferred.
3. Serious candidates with business acumen having technical knowledge would be given preference. There would be no upper age limit to apply.
4. Central/State Govt. officers (including Ministry of MSME)/ can also participate to enhance their knowledge.

**Note: Candidates must carry their working laptop throughout the duration of the event.**

### **PROCEDURE FOR SELECTION OF CANDIDATES:**

1. The selection of candidate will be based on eligibility criteria stated in the '**who can attend**' section, on a first come first serve basis. The final decision on the selection criteria rests upon with the AS &DC (MSME)/Headquarters.
2. The Screened in candidate would be informed about their selection **latest by 23<sup>rd</sup> January, 2025.**
3. Only a maximum of 25 participants are allowed in the 05 days training programme. Preference shall be given to SC/ST/OBC/PwD and Women candidates. Along with IT background and or acumen.
4. After the final selection, participants will be required to submit an undertaking within a specified time frame. Failure to do so will result in their disqualification, and participants from the waiting list will be given the opportunity.
5. Participants are expected to make their own travel and stay arrangements (outstation participants).

### **REGISTRATION:**

**No registration fee is required to attend the program.** However, registration for the course is mandatory through the following google form latest by **15<sup>th</sup> January, 2025.** The selected participant will get a registration kit along with a Certificate of Participation after they attend 80% of the session or above.

## **HOW TO REACH IIIT-ALLAHABAD:**

The sparkling campus of IIIT-A is located in Jhalwa (Peepalgaon Road), Allahabad. It is 10 km from the city center, and 7 km from the main railway station (Allahabad Junction). Allahabad is very well connected by trains from all major cities like Delhi, Kolkata, Guwahati, Mumbai, Chennai etc. Best is to alight on Platform No. 1 side of Allahabad Junction and hire an auto rickshaw for about Rs. 130, depending upon day-night timings of your arrival. Ola and Uber are also functional in the city. Taxi Service is also available from Platform No. 1 (called Chowk side), Platform No. 6/ 10 (called Civil Lines side).

Other Railway Stations under jurisdiction of Allahabad Junction (ALD) are Cheeki (ACOI), Naini (NYN), Allahabad City (ALY) and Prayag (PRG). Allahabad is served by the Bhamrauli Airport, having the code IXD. Direct flights are available from Bangalore, Bhopal, Bhubaneswar, Dehradun, Delhi, Indore, Lucknow, Mumbai, Pune and Raipur.
