CIRCULAR

Subject: Purchase of Goods or Services up to Rs. 25,000/- -- Regarding

Reference is invited to this Office Circular Ref. No: IIIT-A/DR(F&A)/GFR/2019/Fin. 68 dated 18.04.19 (copy attached at Annexure 'A') vide which Amendment in General Financial Rules 2017 was forwarded to all Teaching and Non-Teaching members for information, guidance and compliance. However, during scrutiny of bills of goods up to Rs. 25,000/- on single quotation submitted for payment to the Account Section, it has been observed that goods are being purchased by some sections by resorting to Rule 154 of GFR's 2017 (copy attached at Annexure 'B'), which stipulates that "Purchase of goods up to the value of Rs. 25,000/- on each occasion may be made without inviting quotations or bids on the basis of a certificate to be recorded by the Competent Authority".

In this connection, it is hereby again clarified that consequent upon amendment in GFR's 2017, "As per Rule 149 (copy attached at Annexure 'C'), The GeM portal should mandatorily be utilized by the Government buyers for direct on-line purchases up to Rs. 25,000/- through any of the available suppliers on the GeM, meeting the requisite quality, specification and delivery period".

It may also be noted that in case of non-availability of Goods or Services of required specification or within required delivery period etc.) on the GeM Portal, while submitting the bills for payment to the Accounts Section, it is requested that procuring person through sanctioning authority should clearly certify that the Goods or Services are not available on the GeM Portal on the body of prescribed direct purchase format on single quotation.

The Government of India, Ministry of Finance, Department of Expenditure, Procurement Policy Division, New Delhi vide its Office Memorandum No. F.1/26/2018-PPD dated 02.04.19 has communicated to all Central Govt. Ministries / Departments regarding changes to the GFRs, 2017 for information, guidance and necessary compliance. (copy attached).

(iv) The bidder shall not be debarred unless such bidder has been given a reasonable opportunity to represent against such debarment

Rule 152 Enlistment of Indian Agents. As per the Compulsory Enlistment Scheme of the Department of Expenditure, Ministry of Finance, it is compulsory for Indian agents, who desire to quote directly on behalf of their foreign principals, to get themselves enlisted with the Central Purchase Organisation (eg. DGS&D). However, such enlistment is not equivalent to registration of suppliers as mentioned under Rule 150.

Reserved Items and other **Rule 153** Purchase/Price Preference Policy.

- (i) The Central Government, through administrative instructions, has reserved all items of hand spun and hand-woven textiles (khadi goods) for exclusive purchase from Khadi Village Industries Commission (KVIC). It has also reserved all items of handloom textiles required by Central Government departments for exclusive purchase from KVIC and/or the notified handloom units of Association of Corporations and Apex Societies of Handlooms (ACASH).
- (ii) Ministry of Micro, Small and Medium Enterprises (MSME) have notified procurement policy under section 11 of the Micro, Small and Medium Enterprises Development Act, 2006.
- (iii) The Central Government may, by notification, provide for mandatory procurement of any goods or services from any category of bidders, or provide for preference to bidders on the grounds of promotion of locally manufactured goods or locally provided services.

Rule 154. Purchase of goods without quotation

Purchase of goods upto the value of Rs. 25,000 (Rupees twenty five thousand) only on each occasion may be made without inviting quotations or bids on the basis of a certificate to be recorded by the competent authority in the following format.

"I,, am personally satisfied that these goods purchased are of the requisite quality and specification and have been purchased from a reliable supplier at a reasonable price."

Rule 155

Purchase of goods by Purchase Committee. Purchase of goods costing above Rs. 25,000 (Rupees twenty five thousand only) and upto Rs.2.50,000/-(Rupees two lakh and fifty thousand only) on each occasion may be made on the recommendations of a duly constituted Local Purchase Committee consisting of three members of an appropriate level as decided by the Head of the Department. The committee will survey the market to ascertain the reasonableness of rate. quality and specifications and identify the appropriate supplier. Before recommending placement of the purchase order, the members of the committee will jointly record a certificate as under.

"Certified that we, members of the purchase committee are jointly and individually satisfied that the goods recommended for purchase are of the requisite specification and quality, priced at the prevailing market rate and the supplier recommended is reliable and competent to supply the goods in question, and it is not debarred by Department of Commerce or Ministry/ Department concerned."

Rule 156

(1) Purchase of goods directly under Rate Contract. In case a Ministry or Department directly procures Central Purchase Organisation (e.g. DGS&D) rate contracted goods from suppliers, the prices to be paid for such goods shall not exceed those stipulated in the rate contract and the other salient terms and conditions of the purchase should be in line with those specified in the Rate Contract. The Ministry or Department shall make its own arrangement for inspection and testing of such goods where ever required.

(2) The Central Purchase Organisation (e.g. DGS&D) should host the specifications, prices and other salient details of different rate contracted items, appropriately updated, on the web site for use by the procuring Ministry or Department.

Subject: Replacement of name of erstwhile DGS&D (Directorate General of Supplies & Disposals) by GeM (Government e-Marketplace) in General Financial Rules (GFRs) 2017 - reg.

The undersigned is directed to refer Supply Division, Department of Commerce (DoC) OM No. 1(1)/2018-Pol. Dated 20.08.2018 proposing changes in GFRs, 2017 and to say that the proposal of DoC has been examined and it has been decided with the approval of Finance Minister to make changes to the GFRs, 2017 as tabulated below:
